PROPOSITION I

Shall the Board of Education be authorized to expend an amount not to exceed \$700,000 from the unexpended 2004-05 General Funds for capital improvements as follows: rebuilding of boiler at Riverhead High School; renovation of chimneys at Riverhead High School and Pulaski Street Elementary School; installation of security system at all school buildings; addition of new

science lab at Riverhead High School; upgrading of wiring in computer labs for all school buildings; electrical panel upgrades at Phillips Avenue Elementary School; modification of main offices at Riley Avenue and Phillips Avenue Elementary Schools; HVAC modifications for the music and library areas at the Riverhead Middle School; renovation of gym bleachers at Riverhead Middle

School.”
