Riverhead Central School District

As a volunteer in the Riverhead Central School District, an individual may have access to confidential student information. This information may relate to general items such as address and telephone number or to medical conditions, behavior issues and academic records. A volunteer may also observe situations that he/she does not immediately understand. This type of information about specific students cannot be shared with anyone outside of the school.

Comments, concerns, and opinions regarding students and staff members should be discussed with a school administrator. Questions about discipline and behavior should also be shared with the administrator and not other parents or volunteers. The Riverhead Central School District welcomes the dedicated individuals who come into the schools to volunteer their time and talent to assist the students and staff. However, idle comments made in the community about a student can be extremely detrimental to the child. If the confidential protection afforded to students and staff members is broken, the volunteer will no longer be allowed to work in the school district for the remainder of the school year. The district expects the same professional concern regarding confidential information from volunteers as it does of its employees.
