a. Reliable reports of information from credible sources made known to school officials. If the source is anonymous, the information must show that the informant has a relationship to the school or the student to give credibility.

b. Suspicious or evasive behavior suggesting violation of a school policy or laws, or concealment of contraband or weapons.

c. Observation of a student engaging in prohibited conduct or being in a restricted area.

RIVERHEAD HIGH SCHOOL STUDENT PARKING REGULATIONS

2022 - 2023

1. Students parking in the RHS parking lot must have a valid parking sticker on the passenger side back window of registered vehicle.
2. Parking stickers will be assigned after student has completed the appropriate application. (Applications are available in room 125)
3. No car will be permitted in the parking lot without a current parking sticker.
4. Students are to use the rear parking lot only. STUDENTS ARE NOT TO PARK IN PARKING SPOTS DESIGNATED AS "STAFF" or "VISITOR". Failure to abide to this regulation may jeopardize your parking privileges.
5. Students are **NOT** to park in front of the building.
6. All cars parked in the student parking lot are to be locked during the school day.
7. At no time during the school day are students to sit in cars parked on school grounds.
8. Law prohibits possession of alcoholic beverages or controlled substances on school property. Students who violate this law will be suspended and will have their driving privileges revoked.
9. Any actions or behavior that in any way endangers the health, safety, or welfare of others will result in immediate suspension, loss of driving privileges, and possible referral to the police.
10. Any student who transports unauthorized students on or off campus will be subject to loss of driving privileges for an extended period of time.
11. The Academic Eligibility Policy will apply to parking privileges.
12. Students with chronic attendance/lateness or discipline problems are subject to a loss of driving privileges.
13. **Suffolk County Law prohibits students with a *Junior License* from driving to and from school. This law will be strictly enforced.**
14. Vehicles parked on school district property are subject to inspection and search should the building administration have reasonable suspicion that drugs, alcohol, weapons, or any item(s) that may be considered dangerous or disruptive to the educational process may be concealed in that vehicle.
15. The administration has the right to close campus at any time for the purpose of students' safety.
16. Parking at Riverhead High School is at your own risk. The Riverhead Central School District is not liable for any damages to your vehicle.
